Description of Packaged Options

Direct Cremation Package

Our most selected service, the Direct Cremation Package includes the services necessary to go forward with cremation promptly eliminating the need and additional cost for a formal service. Transportation, filing the death certificate, filling your death certificate order request and the cremation process itself are included. If your goal is to keep things simple, direct cremation is a fitting choice. Urns, keepsakes, or jewelry can be purchased by the family. These items will be filled and prepared by our staff.

Viewing Farewell Package

The Viewing Farewell Package is a formal viewing of the deceased in a traditional wood casket at our chapel followed by cremation. Our beautiful Oak rental casket contains an insert that is removed after the viewing and is then cremated with the deceased. If you want formality but not a funeral we recommend the Viewing Farewell Package.

Cremation & Celebration of Life Package

The Cremation And Celebration Of Life Package is a combination of our direct cremation package described above followed by a celebration of life service at our chapel. Our staff, beautiful chapel facility, memorial folders, and guest registry book are included. The family usually requests that the ashes be present at the service.

Funeral Service with Cremation Package

The Funeral Service with Cremation Package is a formal funeral including the use of our traditional oak rental casket followed by our direct cremation service described above. Our beautiful oak rental casket contains an insert where the deceased is placed. That insert is removed after the funeral and is then cremated.

Funeral Service Package

The Funeral Service Package is formal service with the casket present. A funeral is attended by family and friends. The officiant or speaker performs the service. The funeral director helps you plan your service, whether it's in our chapel, a local church, or graveside.

Graveside Service Package

The Graveside Service Package occurs at the cemetery. The casket is placed over the grave prior to family arriving or the family may opt to carry the casket and place it over the grave from the location where the hearse is parked. The officiant or speaker performs the service.

Receiving Remains From Another Funeral Home Package

Our staff arranges for the deceased to be shipped to our funeral home either by van or by airline.

Forwarding Of Remains To Another Funeral Home Package

Our staff arranges for the deceased to be shipped to another funeral home either by van or by airline.

Immediate Burial Package

The immediate burial package is a burial that is handled by the funeral home exclusively. The family does not attend the burial at the cemetery. This package is for families who prefer burial, but don't want to plan for or pay for the additional cost of a formal funeral. The funeral director coordinates with the cemetery and arranges for burial without a service.

Witness Immediate Burial Package

The Witness Immediate Burial Package is for families that want burial and who want to attend or "witness" the burial at the cemetery without a formal funeral service.
