In order to provide our competitively low prices, **payment is due at the time of the arrangement meeting.** We accept cash, credit or debit cards, and checks.

REGULAR BUSINESS HOURS: 9am – 4pm; the funeral home is closed Saturday & Sunday

REGULAR VIEWING HOURS: 3pm – 5pm or by funeral director approved appointment; the funeral home is closed Saturday & Sunday. Note, a two-day advanced notice by the family is required to schedule a viewing or as approved by the funeral director.

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

DEFINITIONS:

COMMITTAL SERVICE: A committal service at the grave is brief, whereas the graveside service has all of the elements of a funeral, but is held near or next to the open grave depending on the season of the year. The length of the graveside service is the same compared to a funeral service, a committal service is typically fifteen minutes or less.

FORWARD (...or forwarding the remains): The funeral home is hired to ship the remains with either or both van transport or via airline carrier. The funeral home coordinates with the receiving funeral home.

FUNERAL SERVICE: Deceased is present at the service where an officiant addresses the attendees who are typically seated. The funeral is sometimes followed by a committal service at the grave. See definition of committal service above.

GRAVESIDE SERVICE: Deceased is present at the cemetery where an officiant addresses attendees whether seated or standing.

IMMEDIATE BURIAL: There are no attendees at the cemetery at the time the deceased is buried. This arrangement including date and time of the event is coordinated between the funeral home and cemetery only.

CELEBRATION OF LIFE (Memorial Service): The deceased is not present. An officiant addresses attendees whether seated or standing.

RECEIVING (...or receiving the remains): The funeral home is hired to receive the remains from out of state via van transport or via airline carrier.

WITNESS BURIAL: Family present at the cemetery to watch the burial process. The funeral home coordinates with cemetery staff for this event. An officiant is not present, there are no formalities or interaction with cemetery staff with regard to those who gather to watch the burial. The family is expected to watch at a safe distance to avoid accidental contact with heavy equipment required to complete the burial.
